Your claims for regularisation of Stop-gap Lecturers has been re-examined in accordance with law laid down by the Hon'ble Supreme Court of India and Hon'ble High Court of Karnataka in the case of Stop Gap Lecturers. You are placed in Category-III. As there is no need and no vacancy in your present institution and there is need and vacancy exists in K.G.F. First Grade College, K.G.F. and its Management M/S.Golden Valley Educational Trust, K.G.F. has no objection to take you, you have been regularised as Lecturer in Botany, in the K.G.F. First Grade College, K.G.F. with effect from the date of joining.

(2) In case you possess 55% marks in the Master's Degree and a pass in NET/SLET, your pay will be fixed at the minimum of the UGC Pay Scale for Lecturer at Rs.2200-4000 + allowances from the date of regularisation. Otherwise, at present, you will be fixed, in the minimum of the State Pay Scale for Lecturer at Rs.2050-3950 + allowances from the date of regularisation. Meanwhile you will be given an opportunity to acquire the requisite qualification within three years from the date of your regularisation.

(3) Your claims for suitable pay scales will be decided after the receipt of the original documents such as SSLC/Degree/Master Degree certificates and other relevant documents and will be processed by the concerned Regional Joint Director, and, subject to local audit verification. If at any time, it is found that these orders have been obtained by making
