OFFICIAL MEMORANDUM

The Director of Collegiate Education in their order cited under reference (1) above have accorded sanction for the absorption of full-time stop-gap Lecturers working in the KGF First Grade College, Oorgaum, KGF. Accordingly, the following stop-gap Lecturers are absorbed into regular service with effect from 29.1.1992.

The absorption of the above stop-gap lecturers is subject to the following conditions:

1. The recognition for salary grant is purely on a temporary basis subject to verification of their service particulars by the Inspecting Officers of the State Government or by the Audit Officers during the local inspection of the Grant-in-aid accounts of the college.

- ✓ 2. These stop-gap lecturers are deemed to have been absorbed into regular service with effect from 29.01.1992.
3. Their pay has been fixed at the minimum of the time scale of Rs.2200-75-2800-100-4000 as on 29.01.1992. However, they shall not be eligible for claiming any arrears of pay and allowances upto 29.01.1992.
4. They should be able to give instructions in Kannada and English if need be.
5. They should execute the agreement bond as stipulated in Schedule II of Agreement to observe the Code of Conduct.
6. They should be prepared to do the work on part-time basis if the work-load falls for any reason.

They should submit their duty report as regular lecturers to the Principal forthwith.
